### **SB Financial Group Declares Quarterly Cash Dividend on Common Stock of \$0.09 Cents**

Defiance, OH, April 24, 2019 – SB Financial Group (NASDAQ: SBFG) ("SB Financial") announced that its board of directors passed a resolution declaring a quarterly cash dividend of \$0.09 per common share, payable on May 24, 2019, to shareholders of record as of May 10, 2019.

"We are quite pleased to return to our shareholders a common dividend of \$0.09 a share representing a 13 percent increase over the prior year quarter and collectively, for the last four quarters, \$0.34 per share or 13 percent over the previous four quarters." said Mark Klein, Chairman, President and CEO of SB Financial.

Headquartered in Defiance, Ohio, SB Financial is a diversified financial services holding company for the State Bank & Trust Company (State Bank). State Bank provides a full range of financial services for consumers and small businesses, including wealth management, private client services, mortgage banking and commercial and agricultural lending, operating through a total of 20 banking centers; 19 in nine Ohio counties and one center in Fort Wayne, Indiana, and 26 full-service ATMs. The Company has six loan production offices located throughout the Tri-State region of Ohio, Indiana and Michigan.
